Matters Arising from the Minutes:

Pleasure Ground –A Uren has seen Mr Francis and would like to discuss further, ongoing.

Playing Field – R Colville has submitted the grant application and is waiting for the outcome.

P Burden is finishing the new metal frame for the basket swing and will install in the next couple of weeks and lay the chippings for the path into the playing field. He will invoice for the expenses.

The jet wash of the wooden play equipment has been done and paid for.

Mr Prout agreed to repair the pavilion but the work has not yet been completed.

Community Area Partnership (CAP) - the June meeting was missed. R Colville agreed to remain as the representative, but other Councillors will take turns attending the meetings. The next meeting is 4th September and A Uren agreed to attend.

Milestone (or boundary marker?) at Tregeare – A Cox has quote for new, engraved stone £1100 inc VAT. R Colville has quote to dig up and re-use original stone £522. Clerk to see if Laneast are happy to contribute 50% of whichever cost, but hope to re-use stone as would look better.

Village Hall Parking - J. Nettle attended the meeting. The area does not belong to anyone. It was decided that tarmac would not suit and further quotes for concreting would be sought and how to pay to be decided when a suitable quote found.
